

ON ABORTION: THE SILENT HOLOCAUST

With a Discussion on the Spiritual Aspects

My opinions against abortion were formulated over many years of observation and personal experience in dealing with the consequences suffered by mothers who opted to have one or more abortions. The most striking observation that I noted was the large number of women who developed moderate to severe mental depression, guilt and anxiety over having abortion, and often with onset several years after the procedure. Most, however, noted onset relatively soon afterward. Guilt and self-condemnation were, most often, the most difficult of symptoms to deal with, because no amount of talk, no type of psychotherapy, and no known medication is able to erase the recognition and realization that they have willfully and intentionally lost a part of themselves. Just as an amputee who has lost a leg spends the rest of his life with the realization of that loss but learns to cope with it, the same is true of the woman who has had an abortion. The memory of what was once there never goes away. If it did, the woman would not truly be human. Just as an amputee may have flashes of “phantom limb” pain years later if not for the rest of their life, so a woman who has amputated an unborn child from her womb may have psychological pain, remorse and guilt for the remainder of her life. Psychiatrists and psychologists will not cure that. They are not called to engineer built-in happiness, again, into people’s life circumstances. They can only help them to cope and function.

For much of my professional life, I was on the receiving end of these problems for the years that I was in psychiatry, and then, in ministry. Most measures were temporizing, permitting the woman to function, but doing little to take away their pain. Why? Because the most a psychiatrist or psychologist could do, was to empathize with the patient and give support. No doctor could enter their heads, remove their thoughts, readjust their minds, or take away their memories. *Those were there to stay.*

Psychiatry, I found, really did not have the answers. Let’s be practical about this. One never gets over losing a part of themselves, particularly their genetic selves. Never. As much as the abortionist would like to persuade their patient that all will be well thereafter, I could see that most women who suffered the emotional and psychological consequences of such horrible psychic trauma, felt otherwise. Sometimes, even their

husbands or significant others, were traumatized by the event, some even angered. Some were lied to. I had in counseling a woman who had 3 abortions over several years, and was told by her abortionist that she had nothing to worry about because the fetus that was being removed was “not yet human.” Others were told that it was “just a mass of tissue” or “a glob” that was being removed. Some were told anything to minimize the idea that the life of a human being was being terminated. It was all intellectually dishonest.

The reality was that an unborn child was being murdered. Call it what it is. It is made up of human DNA, not cow DNA, not dog DNA, not lamb DNA....but HUMAN DNA. Isn't it interesting that no one argues against a lamb coming from lamb DNA, or a cow coming from cow DNA. But educated men, both physicians, biologists, and legal scholars argue whether a fetus before birth can be considered truly human, and why it has no legal rights. DNA is the molecule of life which genetically predetermines the biological entity to be *what it is, and nothing other than what it is*....the Courts have not figured that one out, at least not yet! Being a living biological human entity, the fetus must have human rights since it is predetermined to be human by its DNA. Its *location* in the womb, is *incidental* to *what it is*. To extend legal rights to functionally independent humans outside of the womb, and not to living humans inside of the womb is biological *and* social discrimination, plain and simple. To say that the mother did not play a voluntary role in conception, in most cases with few exceptions, does not exonerate her from responsibility for creating the circumstance of conception and birth to begin with. There must be an accountability held for that.

In the vast majority of circumstances, being in the womb is not the fault of the unborn child. Is there legal justice in a mother being exonerated from responsibility of participating in the creation of an unborn child, and the unborn child not having any rights to survive, at all, when it did not ask to be there? Does not the unborn child have a right to a purpose and a destiny, just as the mother does? I am not insensitive to difficult circumstances that sometimes emotionally ill-equipped or violated mothers face, but I do know this: that persuading them to abort rather than carry the baby to term and give it up for adoption, only complicates and compounds their problems several-fold later on. That is an almost certain consequence of performing such a willful, unnatural act as abortion. On the other hand, their willingness to do the right thing for the unborn child, confirms their nobility and strengthens their character and acknowledges to the child their willingness to be accountable to it by letting it live. The long-term benefit is that of peace of mind, free of guilt, shame, blame, and condemnation, if not, torment about wondering over and over again if they had made the right decision by aborting. That peace of mind will be with them for the rest of their life. One gesture of mercy to the unborn child in letting it live and be adopted, would, in

most instances, end up giving the mother who was willing to be accountable and merciful, a very big long-term payoff of being free from emotional pain and misery. *Most abortionists are not likely to promote that, however.*

You may argue that these things are the exceptions and not the rule. The vast majority of such physicians are competent and ethical. Perhaps. Abortion, however, is a question of morality. If you would not purposely and intentionally wound your arm or hand, then why would you wound your unborn child? Are they not both a part of you? Do you really think that you can get away with such an act, “scot-free” without paying a consequence that is clearly against the natural order of existence? That says it all.

I would make a proposal to all state governments that permit abortion in their hospitals, whether privately or federally funded: pass a law requiring all doctors who perform abortion to follow their patients post-abortion for a period of 10 years on an annual basis, with periodic independent psychiatric evaluations and follow-up. Or if you are a potential patient considering abortion, propose the same to your abortionist. I promise you, the number of abortions that will be reported in that 10-year period will drop dramatically as will the number of doctors who are willing to perform abortions. There is only one thing that would prevent such a thing from happening: a society that has become so amoral or immoral that it just doesn't care. By all indications, we are well on our way to that. Are you concerned about what kind of life and future your children and grandchildren are going to have in a society that is bent upon social and civil decay? I hope you are. If not, you'd better be because the process has already begun.

May I remind you that one of the greatest and most powerful empires of history, the Roman empire, disintegrated and ceased to exist around 700 AD, not because it was defeated in war or conquered by enemies, but because of rampant dissolution of the family unit through divorce, moral decay, violence and crime and, yes, abortion. The Empire collapsed because it disintegrated from within from decay of family values and the break up of the family unit of which all nations are constructed. These historical facts are well documented in Durant's "The Story of Civilization, Vol.3,, and Gibbon's "The Decline and Fall of The Roman Empire." Alfred Edersheim, Jewish Historian turned Christian, and an expert on ancient Roman and Jewish history at the time of Christ, wrote in his famous writing, "The Life and Times of Jesus The Messiah (1883) , " It has been rightly said, that the idea of conscience, as we understand it, was unknown to heathenism. Absolute right did not exist. Might was right. The social relations exhibited, if possible, even deeper corruption. The sanctity of marriage had ceased. Female dissipation and the general dissoluteness led at last to an almost entire cessation of marriage. Abortion, and the exposure and murder of newly-born children, were common and tolerated; unnatural vices, which even the greatest

philosophers practiced, if not advocated, attained proportions which defy description.” (Cited from Christian Courier, Wayne Jackson). It sounds like a description of our society today. The reason for that is because we are following down the same road to destruction that Rome elected to follow: self-destruction through debauchery. The Christ of God came at that time to provide a remedy, a means of salvation for them: The Gospel. They rejected it and today many still reject it, pursuing right by might, refusal to recognize absolutes exist, and worship of self-will over the Will of God. That, fellow reader, is a recipe for absolute destruction. Edersheim called abortion “murder”. I call it the same. Abortionists can “doctor it up” any way they want to make it look acceptable, but that will not take away from it what it really is: legalized murder in which the government cooperates. You can put lipstick on a pig but it’s still a pig. Society is returning to the same pagan values and practices of both the Greek and Roman Empires. Abortion was rampant in both of those societies. Indeed, it is a very ancient pagan practice.

The number of abortions that have been performed in the United States since 1973, when Roe vs. Wade was passed into law, to the time of this writing is approximately 58,586,256 . God only knows how many great physicians, surgeons, scientists, statesmen and legislators, researchers, attorneys, teachers, scholars, clergy, business men, dedicated workers and laborers, artisans, artists, musicians and good citizens and taxpayers, among the many other good people of this nation we have lost at the hands of a relatively small number of amoral surgeons who performed such procedures over the years. Our nation will pay the consequences for such losses. History repeats itself for those who have not learned from it.

Abortions were being performed much earlier than 1973 but under stricter conditions. During my medical school days and up to 1968, they were referred to as “therapeutic abortion”. As a young psychiatrist, in 1968 I had the opportunity to debate an abortionist on a live radio broadcast in which he was extoling the benefits of “therapeutic abortion” and how it benefited the mother. I pointed out to him that it might have been temporarily “therapeutic” for the mother and his wallet, but it was not “therapeutic” for the baby. Highly insulted, he went ‘ballistic” on-the-air, jumped up out of his chair and began yelling and screaming at me over the microphone, in a rage that he found hard to control. If what he was doing was so noble, why the defensive posture? I was not a Christian at that time but I learned many years later, why? God offends the mind to expose the heart. It is interesting that shortly afterward, the term “therapeutic” was abruptly dropped by obstetricians and gynecologists through their national organizations. I would like to think that, perhaps, I had something to do with that. I had assaulted his stance, his practice, his reputation, his integrity, his motives, his honesty, his actions and his rationalizations. Don’t prosecuting attorneys do that to

murderers in court trials when they are on the stand as defendants? Abortion is nothing less than murder. Yes, murder. *Call it what it is.*

On my review of the history of abortion in the Roman Empire, I was impressed with the number of pagan Roman statesmen and philosophers who opposed abortion and referred to it as murder of the unborn child, and not even as Christian or Jews! It was apparent, however, that despite their high regard and high positions in Roman society, that they were little regarded by the population-at-large because of their moral position. It was a time when societies, then as now, were abandoning moral absolutes to embrace the fallacy that what was right or wrong was only what was right or wrong “for you”. The Bible says, “There is nothing new under the sun.” The decay has already begun in our nation and other nations. What lies ahead for mankind in the not-too-distant future is already prophetically predetermined.

Abortionists are murderers and licensed murderers at that. That is my opinion and I am entitled to express an opinion. I *know* them. I *know* how they operate. The frequent publicity about “sleazy” abortion clinic operations being closed down or raided by police and the frequency with which “sleazy” abortion doctors are arrested who are associated with them, testifies to the quality of doctor that these facilities attract. Do you see many outpatient plastic surgery clinics being raided and closed down? How about outpatient orthopedic clinics? How many outpatient dermatology clinics have you seen raided by police, lately? Does this tell you something? Oh, I know! There are many abortionists who do their work in clean, hospital facilities, perhaps more than those who use outpatient clinics. So what? Does their character, lack of conscience about what they are doing, and willingness to kill an innocent unborn child vindicate them from what they are doing whether they are in an elite hospital surgical suite or a “sleazy” abortion clinic? Such doctors are of the same moral fiber. Of late, they even promote termination of life at birth if the mother requests it. I often wonder if any of them ever thought about how *they* would feel if their mother ever considered aborting *them* before birth? If their mothers were so stressed by the obligations of life that they felt that they just could not bear another child; that they should probably go ahead and abort this fetus. Tell me, Dr. Abortionist, if that was the thinking of your mother before you were born, how would you feel about that? Would you have liked to go through the experience of being aborted and experience the pain of being ripped apart limb by limb by forceps, or your brain being sucked out? Of course you wouldn't. Would it change your thinking about the value of abortion? If you were honest with yourself, I bet it would! You would not even be here! By the way, Doctor, have you thanked your mother, lately, for what she didn't do to you??? Have you counted your blessings, lately, while you take away other people's blessings??? Abortionists are among the most disingenuous people that I have encountered in the medical profession. Every

abortionist should get down on bended knee every night before they go to sleep to thank God that they had a mother who was against abortion and to thank God that they didn't abort him or her!

If a rapist assaulted a pregnant woman with a knife, along a street in her 4th month of pregnancy, and stabbed her in the abdomen or cut her open to cause her to loose her fetus, he would be charged with double murder. An abortionist can essentially do almost the same thing, surgically, cause the woman to loose her fetus, and get paid for doing it by the insurance company and with the hospital's permission. They are sanctioned, approved and encouraged by medical societies, medical associations, hospitals, insurance companies, Planned Parenthood (the ones who sold body parts and organs from aborted, dead fetuses while paying for abortions for some clients), and women's organizations, to name just a few. Why not? Most of them are "in bed" with them and benefit from what they do in one way or another. Medicine has deteriorated from a once noble profession into a state of whoredom. So has the Law profession. That is not to say that there are not good doctors and lawyers out there, because there certainly are. Nothing can or will change the constitutional fiber that makes people what they are, except a good dose of God. Man, left to himself, is naturally idolatrous and will not seek God.

If you are considering an abortion, my recommendation to you is "Don't! **You cannot ever get over loosing a part of yourself.** That is one thing that psychiatry taught me. A psychiatrist or psychologist may try to help you to cope. They may try to assist you in staying functional but they cannot engineer built-in "relief" or assuage guilt, shame, blame, heaviness or depression that comes from purposefully and intentionally loosing a part of yourself. *It just does not work.* There is a sadness and heaviness that is carried for the rest of their life. *Persuasion or pills don't last. The remorse does.* I have had women who had abortions verbalize it to me on more than one occasion . Other doctors have also. Perhaps they won't admit it. How about those who verbalized it to members of their family? "I wish I never had done it." It is all too common. How many times have you read an article in your life entitled "Abortion, A Most Excellent Solution", or something similar to that? In my 54 years of the study and practice of medicine, I have not seen such an article in a medical journal or magazine even one time! Why? Such a lie would be straight from the Pit of Hell.

It absolutely amazes me as to how many physicians and patients go through life living the lie about the acceptability of abortion. They make the issue one of the "feelings" and preference of the mother and "ethical" judgments of her abortionist. The issue is neither. The issue is a *moral* issue. Most women who favor abortion take the position that their body is their own and that they can do with it what they want. It is not an

issue of whether a woman considers the unborn child a human life or not. Her opinion does not enter into it. Usually, the woman in question will take the position that her body is her own, to do whatever she wants with it. Perhaps. But what is in her body, the unborn child, has civil and moral rights independent of her, including the right to live and carry out its purpose and destiny. Its body is not hers to do what she wants with it. Look at it this way: in any circumstance where a person causes the loss of life of another person regardless of the location of the person affected, it is called homicide or murder. The location where it took place is incidental. The same is true of the case of a mother with an unwanted pregnancy. The location of her fetus is incidental to what it is, and in most cases, the mother bore significant accountability for it being there in her womb, with few and rare exceptions. The DNA of the child says everything and determines that it is a human life and nothing but a human life. That fetus is not less than a human without civil rights, the equal of a black slave who was treated much the same and deprived of civil rights while being regarded as less than human by its owners during the Civil War Era.

Does the mother truly have the right to terminate the human life of the unborn child? In most instances of those considering abortion, the women claim that they do. Ben Shapiro aptly points out that there is no difference between the argument for a person's right to abortion, and the argument for slavery that existed in the early 1860's. I did not hear him expound upon it in detail but so cogent was his observation, that I thought it appropriate to do so now in support of him.

In the 1860's, slave owners claimed slaves as their property and claimed that they were not humans but another species; that they could do with them whatever they wanted. It is historically documented that with that reasoning, many disobedient and rebellious slaves were "terminated" and put to death by their owners with relative impunity. Today, we have women claiming the same thing, that their unborn fetus is their property, that it is not human until it can survive by itself outside of the womb, and that until then, it is their right to do with their property whatever they want. They believe that this so-called liberty of ownership even permits them to terminate the life of the fetus. The slave of the 1860's had no recourse to legal defense. The unborn child of this present century who is presented to the abortionist for abortion, has no recourse to legal defense. **The unborn fetus is reduced to the level of a slave in bondage to its master.** The slave of the 1860's was reduced to nothing more than the chattel of the slave owner. Today, the unborn child to be aborted is reduced to nothing more than the chattel of the mother. She is given total and complete authority to do with her "slave", whatever she wishes. If she determines that her "slave" is worthy of death, all she need do is to pronounce the same and ask the executioner to come forth and perform his duties, for which he or she will be handsomely paid. It will be sanctioned by most state

governments and the local hospital will be only too glad to assist in the execution. It will be sanctioned in most cases by the Federal Government. It will never be sanctioned by the Court of Heaven or the Supreme Judge of The Universe.

What the Lessons of Later Life Taught Me

My professional education and explorations into the human mind and into the operations of the human brain brought me to new levels of understanding of what it means to be human. I abandoned psychiatry after several years of study and practice, finding that its goal was incompatible with what I wanted for my patients. I did not just want to keep them functional, I wanted them to be healed but the healing seemed elusive. When I switched training over to neurology and neurosurgery, my interest in human brain function and brain surgery opened up vistas of understanding that brought me deeper into the realization that man was something beyond what I was taught in psychology or psychiatry, or even in religion.

I recalled my studies of Sigmund Freud, MD,, the so-called “Father of Psychiatry”, and the writings of Carl Jung, MD, neurologist and psychiatrist, and the “Father of Psychoanalytic Psychiatry” who had explored the depths of the human unconscious, subconscious, and conscious mind and its relationship to behavior and personality. I was struck by a certain statement that Dr. Jung made in a writing toward the end of his life: *“Unfortunately, it is my fate that other people, especially those who are themselves possessed by demons, think me mad because I believe in these powers. But that is their affair. I KNOW they exist. There ARE demons, all right, as sure as there is a Buchenwald.”* Buchenwald was a Nazi concentration camp where the cremation ovens burned continually and daily for years, and which Jung equated with the demonic. Over many years of research, my personal experiences led me into much of the same demonic experiences that Jung had experienced and for the first time, I realized that Jung, in his day both a famous neurologist and psychiatrist, had stumbled into a trans-dimensional reality that few of his colleagues understood. Eventually, he was even able to produce psychoses within himself to access these supernatural experiences. Colleagues thought that he was losing his mind or going insane. *They overlooked the fact that this brilliant research psychiatrist was able to enter and leave these states of mind at will.* Those close to him knew that he was not insane and that he had complete control over his mind during his experiments on self. My own research and experiences confirmed what Jung was doing but supernatural realizations brought me in a different direction.

As time went on, I found that I could find much of what Jung was experiencing in the Holy Bible. The Scriptures always acknowledged that these things existed, and here they were, right in front of my eyes. This may be hard for some of you to believe. If you choose not to believe me, that is your prerogative. I understand and respect that.

The frank reality of all of this brings us to the experiential conclusion that there is a spirit-world around us and not all of it is holy and placed there by God. Jesus put it succinctly that we judge something if it be of God by the fruit. If the fruit is good and beneficial to the person, it is of God. If it is not, it is not of God. Considering abortion, using Jesus' criterion, we can readily see that it is not of God because it is destructive. Jesus said "Satan comes to kill, steal and destroy.....". In the light of Scripture, then, abortion is Satanic.

Paul the Apostle said in Ephesians 6:12, "Our struggle is not against the flesh, but against principalities and powers, rulers of the darkness, wicked spirits in high places." Sort of a silent majority. They are here today. If you remember nothing else, remember that much, because your denial is what they want, and it can affect your life, your future, and that of your spouse, your children, your grand-children and descendants, their spouses and children to the next 4 generations. They have infiltrated all nations and governments of the world, they are in all of our universities, medical schools, law schools, high schools, and control all level of governments and education, the food supply, medical care, the economy, the environment, education at all levels, hospitals, commerce, churches, even some ministries, etc.. Informed mature Christians refer to the method of operation of the New World Order and plan of carrying out their intentions as "Full Spectrum Dominance". The whole thing is a demonic operation to draw people into a mind matrix, a false belief system full of lies, deceptions, delusions, and fallacies that will lead people into a lifestyle of compromise and abandoned values where "self" becomes a god. Then, anything is permissible. It is all by design. Society is being "designed" by spiritual elements it does not understand.

They have human agents in hospitals, law firms, courts, universities, governments, and news media, to name but a few. They control what they want you to see and hear, and what you and your children learn, all as part of "predictive programming". All of this will lead into enslavement of mankind under the New World Order with its one-world government, one-world religion, one-world economy, one-world money system, and one-world education system; individual rights and privileges will be suspended, as will constitutional rights and national sovereignty, as all come under submission to a world leader who will lead the whole system. The Bible calls him the Antichrist. The Book of The Revelation, a prophetic writing and timeline of end-time events, confirms that men will place their faith in men and not God, that judgment will come swiftly, and that two-

thirds of the earth will be destroyed by fire and its populations destroyed; a tragic end for those who placed their hope upon man and abandoned their reverence for God and His Ways. Before that ultimate destruction there will come a Tribulation Period of judgment against all who practice rebellion and disobedience against the Will of God. Those on the earth will look up, and seeing the coming armies of heaven descending upon the earth, they will raise their fists in the air and curse God, the Scripture says. All of this is a picture of a final end through which a worldwide nuclear holocaust follows. It is predetermined by God that just as all of the seven previous great world empires of history fell, so the final end-time world empire will fall. It will happen as certain as the night follows the day. This is the final culmination of events, the final conclusion of man's desire and efforts to exalt himself against the knowledge of God. Why will it happen? The reason is that over two-thirds of all Bible prophecies have already come true with 100% accuracy. There is no book in existence that can claim that.

The only option out will be Christ alone. It may cost you and your loved ones your lives. But that's all right, because Jesus said "Those who will loose their lives for My sake, will gain it." Scripture says "God is not a man that He should lie." (Nu.23:19) and that Christ is Faithful (Rev.1:5). When the disembodied souls of every man, woman and child that were killed in the Great Tribulation are thereafter found standing before Christ at the Great White Throne Judgment, The Court of Heaven, every one will discover that a divine appointment had been set for each and every one; a date and time, an hour, minute and second when each man, woman, and child will appear before the Lord of Glory to give to Him an account of their life and what they have done. Every woman who has had an abortion, and her husband or "significant other" who condoned it, will be there to try to justify themselves before The Lord. *Even her abortionist will be there.* NO ONE WILL ESCAPE THE JUSTICE OF GOD. The Bible forbids abortion. It is a violation of God's standard. There will be an accountability to Him that no one will escape. It is not I who claim it so. It is the Holy Bible that claims these things. I am simply stating what it says.

There are those who, in their skepticism will say, "But Bern, how do you *know* that this will come true?" The answer to that is quite clear. The Bible is very much a prophetic writing. The entire Book of the Revelation, which speaks, of these things is both a prophecy and a prophetic timetable. There is no book in existence that can claim that. Of all of the many, many Bible prophecies that were historically documented after being spoken, they all came true with, yes, 100% accuracy.

The point is that all who do evil and exalt their will against the Will of God will meet their judgment. Those millions of unborn children who were aborted will be there in attendance. Scripture refers to those who went to The Heaven as "the cloud of

witnesses”. What will they be doing? They will be witnessing against those who terminated their lives and prevented them from fulfilling the purposes and destinies for which God called them into existence. God’s justice will immediately follow. Think about that. Many who consider abortion and go through with it think that everything is over with when the abortion is over and done. ***Nothing could be farther from the truth.*** There is the doctor to pay. And there is heaven to pay. I promise you, it will happen, and it will be real. Those who deny these things are simply “gamblers” with their own souls.

It is of great interest and nobility that nearly 2000 years ago, there were numbers of great statesmen, poets and philosophers of the Roman Empire who were not Christian or Jews, who had the courage to stand up against abortion; although they would, today, be considered pagan in their beliefs, they were still able to deduce from the natural world around them and the natural order of things, that the unnatural act of abortion was both cruel and heinous, a sin and immorality against the natural order of things. Now, some two thousand years later, it is of great interest and nobility that we find that there are still present in existence great non-Christian statesmen, poets, and philosophers, as well as Christians and Jews, who have the courage to stand up against abortion because they have drawn the same conclusions as their predecessors of two millennia ago, that abortion is both unnatural and immoral, a sin against the natural order of things and the God who created it all.

If you have already had an abortion, I encourage you to repent of that sin and find refuge in Christ. He is quick and just to forgive all sin and cleanse from all unrighteousness (1 John 1:9). Scripture teaches that the child you lost no longer is a part of your past but a part of your future. Once you have received Christ, you are pardoned from all sin including abortion. Your child in heaven will not witness against you in judgment but will receive you in love, instead.

If you are contemplating abortion, I *encourage* you to examine all alternatives and be wise in your decisions. Not only does your future depend on the decision you make, but making the wrong decision spiritually causes you and four of your generations to follow, to come under a generations’ curse (Ex.20:5) (Deuteronomy, Chapter 28) . God will not be mocked. *This is straight talk.* It is based upon Holy Scripture, which is Divine Revelation and what I have seen and known medically. It is based upon what I have seen, known, and followed-up psychiatrically and spiritually. You will never get over losing a part of yourself.

An abortionist who reads this writing may take offense to what is written here. That is his prerogative. I am entitled to my opinions and will use my constitutional rights to free

speech to express my opinions clearly and in no uncertain terms. I do not ask or expect any abortionist to agree with me.

Abortion photos demonstrate clearly and in no uncertain terms, the pain, agony, wounds, mutilation and destruction that the unborn child suffers as a consequence of the “handiwork” of the abortionist. Of course, he will not tell you that. He will not show you that. Neither does he care to. After the procedure, his message to you will be “Everything went well!” and probably, “You’re going to be all right!”. Everything went well? Not for the baby. You’re going to be all right? Really? That remains to be determined over time, *a very long period of time*.
